## 8. DSNY Update Goodman, Vigurs, Ryan Merola - Asst. Commissioners

- Containerization all throughout the District go forward model for residential and commercial
- Hamilton Heights Takeaways
  - sealed containers, assigned containers
  - rat sightings down 55% in pilot zones
- Change the way we do trash in NYC
- Prototype truck to pick up containers will be rolled out in about a year
- 10 blocks are currently in the pilot zone
- Viability study 96% success in most city streets
- Should reduce the amount of space that the containers take up including parking
- 149th and St. Nicholas Avenue missing trash cans
- City Data for Rat Mitigation Zones
- City wide number went down 6%
- Rat Mitigation zones went down 14%
- Will work with buildings and staff to determine if they need containers
